2 Findings of the independent agency on Quality of Service

2.1 Cellular Mobile Telephone Service:

The objective assessment of quality of service of the service providers, namely, M/s Aircel, Airtel, BSNL GSM, Etisalat, Idea, Loop, RCOM GSM, TATA GSM, Videocon, Vodafone, MTS CDMA, RCOM CDMA and TATA CDMA was conducted during the period from January, 2011 to March, 2011.
